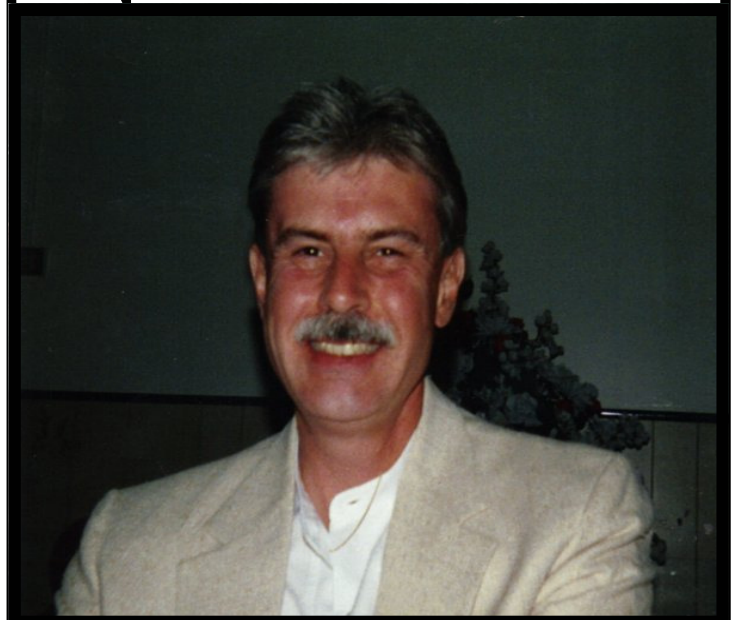
Become informed and educated. Write or call your representatives today. Guardianship destroys families and isolates families. Guardianship is a nightmare.

IMAGINE IF YOU CAN

- ◆ **You are married;**
- ◆ **Your spouse and soul-mate becomes physically disabled and incapacitated;**
- ◆ **It is suggested to you that you need legal guardianship of your spouse so you can make decisions on their behalf;**
- ◆ **You seek legal advice and file a petition for guardianship;**
- ◆ **The County Department of Social Services is ultimately appointed “guardian of last resort” for your spouse;**
- ◆ **You are immediately removed from having any say in the care and treatment of your spouse;**
- ◆ **Your spouse’s personal property and estate is seized, liquidated and your spouse is then Medicare/Medicaid eligible,**
- ◆ **You are told you can only visit your spouse for six hours per week, and only when supervised by paid “interlopers”.**

IS THIS AMERICA ??

FROM BAD TO WORSE

While your spouse and loved one is physically in the care, custody and control of the local government they are the victim of:

- ◆ **Substantiated resident abuse in a county nursing home;**
- ◆ **Substantiated medical neglect by a local hospital;**
- ◆ **Unexplained and unusually high numbers of surgeries, infections, incidents and medical procedures;**
- ◆ **Social isolation to the extent that NO ONE can visit who is not “approved” or on a list; and,**
- ◆ **An attempt by the Adult Protective Services agency to withhold nutrition and hydration to end life.**

This is the life of Gary Harvey over the past four-plus years, and there is more still to this story
